CalRecycle Farm and Ranch Solid Waste Cleanup and Abatement Grant (offered three times a year)

- The California Integrated Waste Management Board administers the Farm and Ranch Solid Waste Cleanup and Abatement Grant Program for the cleanup of illegal solid waste sites on farm and ranch property. A site may be eligible for funding of the parcel(s) is (are) zoned for agricultural use, where unauthorized solid waste disposal has occurred, and where the site(s) is (are) in need of cleanup in order to abate a nuisance or public health and safety threat and/or a threat to the environment.
- Sites are NOT eligible for funding if the owner is the one responsible for the illegal disposal of solid waste.

- A pesticide container rinse certification is required before disposing of or recycling pesticide containers. The certification certifies that the pesticide containers have been triple-rinsed or rinsed in a closed system, in accordance with Section 6684 of the California Code of Regulations. To obtain a rinse certification, please call the Ag Commissioner's Office at 209-385-7431.
